



**2017 SOUTHERN OREGON SMOKED SALMON FESTIVAL

Dear Competitor,

We are excited to announce that competitor registration for the 2017 Southern Oregon Smoked Salmon Fest has now opened and **will remain open until August 31st, 2017**. There are **limited competitor spots** so we highly encourage you to sign up early to secure your spot for Southern Oregon's premiere smoked salmon competition! The festivities will once again be located at **Pear Blossom Park in Medford, OR** and will take place on **September 23rd, from 1-5pm**.

Entry to the smoked salmon competition is \$30. **1st place will receive a \$1,000 cash prize, 2nd \$500 and 3rd \$250, which** will be decided by a panel of prominent local chefs, community leaders, and avid fisherman. The **1st place winner of the "People's Choice" award will receive the People's Choice Trophy and a prize package**. Pay for your registration here:

2017 Competition Details:

- Competitors will provide samples of smoked salmon, enough for over 500 people (3-5lbs of salmon, weight will be verified before the event begins).
- There will be 10 tables at the competitor section in Pear Blossom Park; you will share a table/"booth" with another
- The blind judge tasting will take place from 1-2:00pm, during which time your salmon will be given a number, judges will taste all samples and rank their top choices for 1st, 2nd & 3rd place. Open tasting for the "People's Choice" will take place from 1:00-4:00pm. Competitors will be at their assigned booth and interacting with the attendees, explaining your smoking process, and why they should vote for you for "People's Choice!"
- Event attendees will be given 3 voting tickets each upon entrance to the event with the opportunity to buy Votes will be tallied at 4:00pm. Judge's selection for 1st, 2nd and 3rd place selected by our Judge's and People's Choice award will be announced at 4:30pm.

Your entry fee includes a booth space, sample trays, admission for yourself and a "plus-one" (2), and (2) sampling passports. All competitors will be mentioned during the event and when we announce the results.

100% of the event proceeds will benefit Maslow Project, a local nonprofit that provides support services to homeless youth and families throughout Southern Oregon.
